TRADITIONAL

Before the Standardisation meeting you must mark at least 10 scripts from several centres. For this preliminary marking you should use **pencil** and follow the **mark scheme**. Bring these **marked scripts** to the meeting.

MARKING

1. Mark strictly to the mark scheme.
2. Marks awarded must relate directly to the marking criteria.
3. The schedule of dates is very important. It is essential that you meet the scoris 50% and 100% (traditional 50% Batch 1 and 100% Batch 2) deadlines. If you experience problems, you must contact your Team Leader (Supervisor) without delay.
4. If you are in any doubt about applying the mark scheme, consult your Team Leader by telephone, email or via the scoris messaging system.

5. Work crossed out:
- where a candidate crosses out an answer and provides an alternative response, the crossed out response is not marked and gains no marks
 - if a candidate crosses out an answer to a whole question and makes no second attempt, and if the inclusion of the answer does not cause a rubric infringement, the assessor should attempt to mark the crossed out answer and award marks appropriately.
6. Always check the pages (and additional objects if present) at the end of the response in case any answers have been continued there. If the candidate has continued an answer there then add a tick to confirm that the work has been seen.
7. There is a NR (No Response) option. Award NR (No Response)
- if there is nothing written at all in the answer space
 - OR if there is a comment which does not in any way relate to the question (e.g. 'can't do', 'don't know')
 - OR if there is a mark (e.g. a dash, a question mark) which isn't an attempt at the question.
- Note: Award 0 marks – for an attempt that earns no credit (including copying out the question).
8. The scoris **comments box** is used by your Team Leader to explain the marking of the practice responses. Please refer to these comments when checking your practice responses. **Do not use the comments box for any other reason.** If you have any questions or comments for your Team Leader, use the phone, the scoris messaging system, or e-mail.
9. Assistant Examiners will send a brief report on the performance of candidates to their Team Leader (Supervisor) via email by the end of the marking period. The report should contain notes on particular strengths displayed as well as common errors or weaknesses. Constructive criticism of the question paper/mark scheme is also appreciated.

Question papers and Mark Schemes are developed in association with each other so that issues of differentiation and positive achievement can be addressed from the very start.

This Mark Scheme is a working document; it is not exhaustive; it does not provide 'correct' answers. The Mark Scheme can only provide 'best guesses' about how the question will work out, and it is subject to revision after we have looked at a wide range of scripts.

The Examiners' Standardisation Meeting will ensure that the Mark Scheme covers the range of candidates' responses to the questions, and that all Examiners understand and apply the Mark Scheme in the same way. The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co-ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co-ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- 1 The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- 2 The specific task-related indicative content for each question will help you to understand how the band descriptors may be applied. However, this indicative content does not constitute the mark scheme: it is material that candidates might use, grouped according to each assessment objective tested by the question. It is hoped that candidates will respond to questions in a variety of ways. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- 3 Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.

	Generic mark scheme for Question 1(a) and Question 2(a): Which of the following? [10]
Level 6 9–10 marks	Both factors are thoroughly analysed and evaluated using accurate and detailed knowledge and understanding of key features of the period, in order to reach a developed and substantiated judgement in relation to the question.
Level 5 7–8 marks	Both factors are analysed and evaluated using generally accurate and detailed knowledge and understanding of key features of the period, in order to reach a substantiated judgement in relation to the question.
Level 4 5–6 marks	Both factors are analysed and evaluated using relevant knowledge and understanding of key features of the period, however treatment of factors may be un-even with analysis and evaluation of one of the two being only partial. Analysis and evaluation is used to support a reasonable judgement in relation to the question.
Level 3 3–4 marks	Both factors are analysed and evaluated in a partial way, using some relevant knowledge of key features of the period, in order to make a basic judgement in relation to the question.
Level 2 2 marks	Limited and generalised knowledge of the period is used to attempt a limited analysis or evaluation of both factors, and this is linked to a very simplistic judgement.
Level 1 1 mark	Very limited and generalised knowledge of the period is used to attempt a very limited analysis or evaluation of one of the factors. The other factor is either not considered or there is very limited information or description of the factor with no attempt to use this knowledge. If there is a judgement, this takes the form of assertion.
0 marks	Nothing of any relevance to the factors.

	Generic mark scheme for Question 1(b) and Question 2(b): Essay [20]
Level 6 17–20 marks	There is a consistent focus on the question throughout the answer. Accurate and detailed knowledge and understanding is demonstrated throughout the answer and is consistently evaluated and analysed in order to reach substantiated, developed and sustained judgements. There is a well-developed and sustained line of reasoning which is coherent and logically structured. The information presented is entirely relevant and substantiated.
Level 5 13–16 marks	There is a mostly consistent focus on the question. Generally accurate and detailed knowledge and understanding is demonstrated through most of the answer and is evaluated and analysed in order to reach substantiated judgements, but these are not consistently well-developed. There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
Level 4 10–12 marks	The question is generally addressed. Generally accurate and sometimes detailed knowledge and understanding is demonstrated through most of the answer with evaluation and some analysis, and this is used appropriately to support the judgements that are made. There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
Level 3 7–9 marks	The question is partially addressed. There is demonstration of some relevant knowledge and understanding, which is evaluated and analysed in parts of the answer, but in places knowledge is imparted rather than being used. The analysis is appropriately linked to the judgements made, though the way in which it supports the judgements may not always be made explicit. The information has some relevance and is presented with limited structure. The information is supported by limited evidence.
Level 2 4–6 marks	The focus is more on the topic than the specific demands of the question. Knowledge and understanding is limited and not well used, with only limited evaluation and analysis, which is only sometimes linked appropriately to the judgements made. The information has some relevance, but is communicated in an unstructured way. The information is supported by limited evidence and the relationship to the evidence may not be clear.
Level 1 1–3 marks	The answer relates to the topic but not the specific question. The answer contains only very limited relevant knowledge which is evaluated and analysed in a very limited way. Judgements are unsupported and are not linked to analysis. Relevant knowledge is limited, generalised and poorly used; attempts at argument are no more than assertion. Information presented is basic and may be ambiguous or unstructured. The information is supported by limited evidence.

1	(a)	<p>Which of the following had the greater impact on the authority of the monarchy in 1789?</p> <p>(i) The storming of the Bastille</p> <p>(ii) The October Days</p> <p>Explain your answer with reference to both (i) and (ii).</p> <ul style="list-style-type: none"> · In dealing with the storming of Bastille, answers might suggest that the emergence of the power of the crowds was important as subsequent explosions of popular anger were significant. · Answers might suggest that this was the first clear indication of the loss of royal authority and inability to control Paris and that the Crown's failure to use its forces signalled a lack of will to maintain power. · Answers might suggest that the acceptance of violence by the reforming upper and middle class led to radical groups employing the crowd later in the revolution. · In dealing with the October Days, answers could look at the threats to the royal family at Versailles and their enforced return to Paris as undermining authority. · Answers could look at the role of the National Guard in accompanying the crowds to Versailles. · Answers could consider the results of the King being forced to reside in the centre of Paris, subject to the radically-inspired crowds. 	10	<ul style="list-style-type: none"> · No set answer is expected · Judgement must be supported by relevant and accurate material. · Only credit material relevant to the 'impact on the authority of the monarchy'. · Answers may deal with each factor in turn, then compare them to reach a judgement, or make take a continually comparative approach. 1	(b)*	<p>'Napoleon's rise to power to 1799 was mainly the result of the weaknesses of the Directory.' How far do you agree with this statement?</p> <ul style="list-style-type: none"> • In arguing it was, answers could point to the instability of the Directory and the attempts by both right and left to overthrow it. • Answers could point to poor leadership, corruption and indifferent performance in war. • Answers could refer to the plotting and collusion with Napoleon by key figures which led to Brumaire. • In arguing that it was not, answers could point to the strengths of Napoleon as a general, for instance in the Italian campaign which made him a possible candidate. • Answers could point out that he used propaganda and self-promotion very effectively. • Answers might point to the strength of Napoleon's allies at Brumaire even if Napoleon did not act decisively and then to the confidence Napoleon had in building personal power. 	20	<ul style="list-style-type: none"> • No set answer is expected. • At higher levels candidates will focus on whether Napoleon's rise was 'mainly' a result of the weaknesses of the Directory, but at Level 4 may simply list reasons for his rise. • At Level 5 and above there will be judgement as to the relative success. • At higher levels candidates might establish criteria against which to judge success; this might include aims, success for whom etc. • To be valid judgements, claims must be supported by relevant and accurate facts. If not, they are assertions. • Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.

2	(b)*	<p>How important were the financial problems of the Crown in bringing about the French Revolution in 1789?</p> <ul style="list-style-type: none"> • In arguing that they were, answers might consider the failure to revise an unfair system which contained fiscal privilege and led to unrest. • Answers might consider that problems led to the calling of the States General which was a key element in revolution. • Answers might consider that the problems showed the weakness of the crown to enforce its will, e.g. in the Assembly of Notables and encouraged criticism and opposition. • In arguing that the other factors were more important, answers could consider underlying social inequalities and dissent and economic distress. • Answers might consider Enlightenment political and social ideas. • Answers might suggest that the weakness of the King was the more important factor. 	20	<ul style="list-style-type: none"> • No set answer is expected. • At higher levels candidates will focus on 'how important', but at Level 4 may simply list the causes. • At Level 5 and above there will be judgement as to the relative importance of the factors. • At higher levels candidates might establish criteria against which to judge the most important factor. • To be valid judgements, claims must be supported by relevant and accurate material. If not, they are assertions. • Knowledge must not be credited in isolation, it should only be credited where it is used as the basis for analysis and evaluation, in line with descriptions in the levels mark scheme.
