## Assessment

Units need to be assessed in line with the Skills for Care and Development QCF Assessment Principles.

Assessment decisions for competence based learning outcomes (eg those beginning with 'Be able to') must be made in a real work environment by an occupationally competent assessor. This unit requires workplace assessment of occupational competence.

Competence based assessment must include direct observation as the main source of evidence.
