NEW EDUCATION AND TRAINING STANDARDS CONSULTATION, YOUR VIEWS SOUGHT

A MESSAGE ON BEHALF OF THE EDUCATION & TRAINING TRAILBLAZER GROUP

In 2013 the Government announced reforms to the way apprenticeships will be designed and implemented in England. New standard-based apprenticeships will replace current frameworks in 2015 as part of the Government's employer driven Trailblazer Strategy.

A group of Education and Training employers working on behalf of the Education and Training sector have been leading this redesign. We are asking key stakeholders to get involved and have your say on the essential knowledge, skills and behaviours that teachers should display on completion of their Education and Training Apprenticeship.

Please read and consider the four Education and Training Standard documents which accompany this Notice and consider what you, as an Education and Training employer or teacher, would expect to see from your apprentices.

We would ask you to:

- Examine and reflect on the Education and Training Apprenticeships Standard documents which outline the occupation profiles required by a person in a teaching role at four different levels.
