Subject: GCSEs, AS and A Levels reformed for first teaching in September 2015

# Is your centre teaching the new reformed OCR GCSE (9–1), AS and A Level qualifications this September?

The first tranche of the new reformed GCSE (9–1), AS, and A Levels are available for teaching in England and Northern Ireland\* (see below for exceptions in Northern Ireland) from September 2015. If your centre is teaching a two-year GCSE (9–1), AS or A Level, or a one-year AS Level course this year (15/16) in any of the tranche 1 subjects, you need to be teaching the new reformed specifications.

#### GCSE (9–1)

In tranche 1 new GCSE (9–1) qualifications have been developed in English Language, English Literature and Maths, as follows:

#### **Intention to Teach**

September 2015 is the start of a significant programme of change to the UK curriculum and, as such, we need to collect additional information from centres about the specifications that will be taught from 2015. We're referring to this process as 'intention to teach' and we'll be asking for information about which of our new specifications you'll be teaching at your centre, the size of the cohort, and a contact name and email address for the subject. You'll receive an e-alert in September with a link to the online form and instructions on how to complete it. And, as this is the first year we're asking for this information, if you complete the form by the 10 October, you'll be entered into a prize draw to win an iPad.

Our aim is to help you at every stage of the introduction of a new specification and we're working hard to provide a practical package of support in close consultation with teachers and other experts. \* DENI requirements for GCSE English Language and AS/A Level sciences in Northern Ireland are different to requirements in England. Centres in Northern Ireland will need to take the reformed <u>CCEA</u> specifications in these subjects. To support centres with the transition to the reformed CCEA specifications, we have extended our GCSE English Language (NI) (J345) and AS/A Levels in Biology (H020 / H420), Chemistry A (H032 / H432) and Physics A (H156 / H556) in Northern Ireland (last assessment summer 2017).
