You should explore the contextual themes given below to choose **one** to set your own product development challenge.

Recognising that all design and technology practice takes place within contexts which inform outcomes, you should explore the contextual theme you have chosen to identify problems and opportunities that offer possibilities when considering an approach to your product development and when writing your own design brief.

You must create a portfolio to support the iterative process of product development. The portfolio must deliver:

- a chronological account of your design process
- photographs and videos as appropriate, of your final prototype(s) that clearly demonstrate your practical outcome.

The contextual themes **must not** be altered.

1. Protection of personal identity in public spaces.

OR

2. Kitchens for an ageing population.

3. Cooling the body in a world of global climate change.
