You are reminded that you must use relevant original sources in your answer, and that marks are awarded for the quality of written communication in your answer.

- To what extent do the sources suggest that the Senate was too subservient to be an effective force under the principate during this period? [50]
- 6 How important were family and friends for emperors gaining and maintaining their power and position during this period? [50]
- 7 'Due to neglect by the emperors, the city was unsafe and unrewarding for its citizens during this period.' How far do the sources support this view? [50]
- 8 'By the use of patronage, bribery and force emperors of this period effectively dealt with any challenges during their reigns.' How far do you agree with this view? [50]

#### Option 3: Ruling the Roman Empire AD 14–117

Answer **two** questions.

You are reminded that you must use relevant original sources in your answer, and that marks are awarded for the quality of written communication in your answer.

- 9 'The support of the army was the main reason the emperors of this period were able to maintain control of the Empire.' To what extent do you agree with this view? [50]
- 10 To what extent do the sources support the view that the quality of government of the Empire improved during this period?

- 11 To what extent did the Roman emperors have consistent and coherent policies for the Northern and Eastern frontiers? [50]
- 12 'The provincials' lives were transformed economically and socially by the Empire during this period.' How far do the sources support this view? [50]
