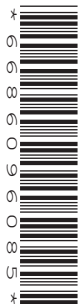

### SECTION A

Answer **at least** two questions from this section.

- 1 (a) Describe the organisation and work of a barrister **and** the options available for a client to make a complaint. [18]  
(b)\* Discuss the problems facing someone wishing to train as a barrister. [12]
- 2 (a) Describe how an individual becomes a lay magistrate **and** a member of a jury. [18]  
(b)\* Discuss the advantages of using lay magistrates rather than professional judges. [12]
- 3 (a) Describe the powers of the police to stop and search **and** arrest a person on the street under the Police and Criminal Evidence Act 1984. [18]  
(b)\* 'An individual's rights are adequately protected during searches at the station.'  
Discuss the accuracy of this statement. [12]
- 4 (a) Describe the qualifications, selection **and** training of inferior judges. [18]  
(b)\* Discuss whether the training provided by the Judicial College makes sure that judges are adequately prepared for their role. [12]
- 5 (a) Describe the jurisdiction of the County Court **and** how it is decided which track a claim should be allocated to. [18]  
(b)\* Discuss the disadvantages of using the courts to solve a civil dispute. [12]

**SECTION B**

Answer **at least** one question from this section.

- 6 (a) Describe the aims of sentencing **and** the aggravating factors that may be taken into account when sentencing. [18]

(b)\* John, an 18-year-old alcoholic, has been found guilty of being drunk and disorderly. He has no previous convictions. Katie, aged 28, has been found guilty of the serious offence of inflicting grievous bodily harm. This is her third conviction for violence against others.

Explain which aims and factors are likely to be taken into account when sentencing both John and Katie **and** the most appropriate sentence in each case. [12]

- 7 (a) Describe how both the police **and** the courts decide whether or not to grant a suspect bail. [18]

(b)\* Giovanna has been charged with manslaughter following her involvement in a fight. She has one previous conviction for minor criminal damage many years ago but failed to comply with bail conditions on that occasion. She currently runs a local business and owns her own home in Italy.

Explain which factors are likely to be considered when making a decision regarding bail for Giovanna and details of the most appropriate condition. [12]
