## **INSTRUCTIONS FOR TEACHERS**

Teachers are reminded that they should use their professional judgement to determine the suitability of the content of learners' productions – see section 3a of the specification.

## Immediate guidance or supervision

Any support that is given to assist a learner should be recorded on the cover sheet, whether this is direct assistance or due to health and safety requirements within the school.

#### What teachers can do

Teachers may review work before it is handed in for final assessment. Advice must remain general, enabling learners to take the initiative in making amendments.

Teachers may give advice on:

- the suitability of locations
- the technical resources available
- the need for a professional working relationship if the learner is using unassessed learners to support the production
- the appropriateness of production schedules
- health and safety issues that may arise.

#### What teachers cannot do

Teachers may not give detailed advice and suggestions as to how the work may be improved in order to meet the assessment criteria. This includes intervening to improve the presentation or content of the work.

Further guidance about the nature of advice that teachers can give to learners may be found in the JCQ publication *Instructions for conducting non-examination assessments*.

## Creating media (J200 03/04) - NEA indicative content

The 'indicative content' is an example of valid content relating to the Non-Examination Assessment Materials. Any other valid content produced is acceptable and should be credited in line with the levels of response.

The 'indicative content' shown is an example of valid content for the Non-Examination Assessment Materials and is not a full exemplar production. It is not expected for candidates to cover all elements of the indicative content.

## **Brief 1: Magazines**

Create a front cover and a double-page spread article for a music magazine aimed at a socially conscious audience.

Learners are likely to include:

- · content that meets the set brief by creating meaning for a socially conscious audience
- use of typography appropriate to a music magazine aimed at a socially conscious audience to create a sense of variation within a consistent house style
- use of layout appropriate to a music magazine aimed at a socially conscious audience to create a sense of variation within a consistent house style across the front page and double-page spread, including page size and page design (use of graphics, colour, headings, columns, the relationship between image, copy and space)
- use of language that appropriately addresses a socially conscious audience through its vocabulary, register, tone and mode of address
- choice of mise-en-scène in photography appropriate to a music magazine aimed at a socially conscious audience, showing consideration of location, sets, lighting, costume, props, casting, blocking and performance
- a range of shots appropriate to a music magazine aimed at a socially conscious audience including variation in angle, composition, framing and shot distance
- use of representations that are appropriate to a music magazine aimed at a socially conscious audience
- a clear attempt to construct a particular representation
- viewpoints, messages, values and beliefs that attempt to reflect those of a socially conscious audience.

#### **Brief 2: Television**

Create two minutes of opening scenes, with a title sequence, for a television comedy programme aimed at a socially conscious audience.

Learners are likely to include:

- a sequence that meets the set brief by creating meaning for a socially conscious audience
- choice of mise-en-scène appropriate to the opening scenes of a television comedy programme and a socially conscious audience showing consideration of location, sets, lighting, costume, props, casting, blocking and performance
- variation in shots as appropriate to a socially conscious audience, the genre and the tone of the programme including use of camera movement and variation in angle, composition, framing and shot distance
- use of editing pace to support the sequence
- continuity editing, with possible use of montage or justified breaks in continuity as appropriate, to engage a socially conscious audience
- use of soundtrack to construct a sequence, establish continuity, fit generic conventions and create tone to engage a socially conscious audience
- use of representations that are appropriate for the opening scenes of a television comedy programme aimed at a socially conscious audience
- a clear attempt to construct a particular representation
- viewpoints, messages, values and beliefs that attempt to reflect those of a socially conscious audience.

Accept any plausible interpretation of the term 'socially conscious'. Candidates should briefly explain the social, cultural, political or environmental concerns of their intended audience in their Statement of Intent in order to make this clear to the assessor or moderator.

Create a two-minute sequence of an original music video to accompany a protest song aimed at a socially conscious audience.

Learners are likely to include:

- a narrative that meets the set brief by creating meaning for a socially conscious audience
- use of mise-en-scène appropriate to music videos and a socially conscious audience showing consideration of location, sets, lighting, costume, props, casting, blocking and performance
- a range of shots appropriate to music videos including appropriate use of camera movement and variation in angle, composition, framing and shot distance
- appropriate pace of editing for music videos
- use of editing devices to create a sense of style and match the tone of the music
- use of representations that are appropriate for a protest music video aimed at a socially conscious audience
- a clear attempt to construct a particular representation
- viewpoints, messages, values and beliefs that attempt to reflect those of a socially conscious audience.

Accept any plausible interpretation of the term 'socially conscious'. Candidates should briefly explain the social, cultural, political or environmental concerns of their intended audience in their Statement of Intent in order to make this clear to the assessor or moderator.

Accept any music that can be plausibly defined as a protest song, in any musical genre. This may include a song explicitly written as a protest song or any song adopted by audiences as a protest song (whatever its original intention).

## **Brief 4: Online, Social and Participatory**

Create a homepage and one linked web page for a campaigning website targeted at a socially conscious audience.

Learners are likely to include:

- content that meets the set brief by creating meaning for a socially conscious audience
- use of typography appropriate to the campaigning website and a socially conscious audience to create a sense of variation within a consistent house style
- use of layout appropriate to a campaigning website and a socially conscious audience to create a sense of variation within a consistent house style, including page size and dimension, and page design (use of layout grids, logos and other graphics, navigation bars, background, colour, headings, columns, the relationship between image, copy and space)
- a clear structure with easily identified links and, as appropriate, search facilities
- opportunities for audience interactivity and user-generated content and links to social media, as appropriate
- use of language that appropriately addresses a socially conscious audience through its vocabulary, register, promotional tone and mode of address
- use of photography with consideration of camerawork and mise-en-scène
- embedded video or audio with consideration of soundtrack, mise-en-scène, camerawork and editing, as appropriate
- use of representations that are appropriate for a campaigning website targeted at a socially conscious audience
- a clear attempt to construct a particular representation
- viewpoints, messages, values and beliefs that attempt to reflect those of a socially conscious audience.

Accept any plausible interpretation of the term 'socially conscious'. Candidates should briefly explain the social, cultural, political or environmental concerns of their intended audience in their Statement of Intent in order to make this clear to the assessor or moderator.

Learners are not required to create websites through programming languages such as HTML and can use web design software or templates for the online briefs. Learners must be responsible for the design of the website and all content (such as text, images and audio-visual material), apart from the permitted found images, must be original. Learners must acknowledge any software or templates they have used on the Cover Sheet.
