

Before sitting an examination or part of any assessment that will contribute to a qualification, a private/external candidate or transferred candidate who is **not** known to the exam centre, school or college must show photographic documentary evidence (eg a passport or photographic driving licence) to prove they are the same person who is entered/registered for the examination or assessment.

If a candidate does not have photographic evidence, this form may be completed and provided to the centre **when an entry is made** instead. It should be retained by the Head of Centre or the Exams Officer, so the candidate's identity can be confirmed by centre invigilation staff before each examination or assessment. **Two** passport-sized photographs (one of which must be signed on the reverse by the person identified in part 3 below) must be included.

Centres **must** keep the original copy of this form at the centre. It must be used to visually check the candidate's identity against the entry details for the candidate every time they sit an examination/assessment.
